Insurance, penalties, price increases and other important information

DEPOSIT

Your deposit will guarantee your cabin on the cruise. Although it is rare, from time to time, the cruise line may add fuel surcharges or new government taxes. In this case, your price may change. Once we run out of the cabin allocation for the wedding prices may change. It is important that you do not miss the deposit and final deadlines because your cabin price can go up and we will charge a \$10 fee per person to reinstate a missed deadline in a group booking.

OPTIONAL INSURANCE AND CANCELLATION

Once your deposit is applied, there is a penalty to cancel or change your reservation. Optional travel protection or travel insurance is available and is strongly recommended. This insurance provides you with protection while you are traveling and will cover most (not all) fees if you were to change or cancel your reservation due to a covered reason. We will charge you \$50 per person cancellation fee in addition to any cruise/air penalties or insurance. You have two choices of insurance. One from the cruise line directly. Go to www.dorothydawntravel.com and click on insurance on the right hand side. For a more comprehensive insurance call 1-800-235-7178 and give ID #05-8168. Tell them the total cost of the cruise and your air and they will tell you the full insurance price.

RECONFIRM YOUR AIR

AND BE EARLY FOR AIR AND CRUISE
Due to recent airline industry changes please RECONFIRM your flight with the airline 24hrs in advance. Be at the airport at least 2 hours in advance. If we book your air through the cruise line your seat assignments will be done by the airline and are automatically based on their space allocation formula, if booked early enough. You may call the airline 2-3 weeks prior to departure to change seat assignments. It is

extremely important that the names on the enclosed form are exactly as they appear on your passport, as incorrect name spelling may result in denied boarding. Be at the cruise terminal at least 2 hours early. After you make the final payment please go on cruise line site and fill out registration ahead of time to ensure US security compliance. You will need your booking number.
