Women who are entering their 24<sup>th</sup> week of pregnancy at the time of the sailing will not be allowed to board the ship. It is recommended that all pregnant women, not yet past 24 weeks obtain a "Fit to Travel" letter from their doctor.

**A deposit of \$25.00 per person** is due no later than **5/28/08** to guarantee group rates and participate in group on-board activities. A payment of \$200 is due on **09/01/08**. Full payment is due **11/03/08**. **Penalty dates** are 11/02/08 of \$225 per person, 12/6/08 50% plus \$25 per person and on 12/22/08 100% plus 25% per person. Cruise lines do not make exceptions. **The final payment will be due no later than 11/01/08. It will be automatically charged on your credit card.**

Prices are per person including taxes and port charges. Air, transfers to the ship, tips or possible cruise fuel charges are extra. You will receive an e-mail when the pricing has been confirmed. Pricing is subject to change until confirmed.

## DISCLOSURES

Person who books the cabin is responsible for informing his/her guests of these conditions

### DEPOSIT

Your deposit will guarantee your cabin on the cruise and participation in any wedding activities and dining. On rare occasions, the cruise line may add additional fuel surcharges, port charges or taxes which are beyond their control. In this case, your price may change to reflect these charges. If the group allocation runs out the booking will be made at prevailing prices, so please reserve early. Booking in a group guarantees on-board participation in group activities. Missed deadline dates will result in penalties and/or cancellations of cabin.

### CHANGES

Changing the number of people in a cabin affects the pricing of the rest of the travelers in that cabin. If you have 2 people and one cancels the other person will have to make up the difference. Changing names and people is also subject to penalties which vary depending on how close the sailing is. Usually there are no change penalties for changes prior to second deposit.

### OPTIONAL INSURANCE AND CANCELLATION

Once your second deposit is applied, there is a penalty to cancel or change your reservation. Check the penalty deadlines on page 1. Optional travel protection or travel insurance is available and is strongly recommended. Insurance decision can be made by time of second deposit. This insurance provides you with protection while you are traveling and will cover most (not all) fees if you were to change or cancel your reservation due to a covered reason. After the second deposit TravelMaker will charge you \$25 per person cancellation fee in addition to any cruise/air penalties or insurance. Check for a link to insurance rules on the website.

### RECONFIRM YOUR AIR AND BE EARLY

Due to recent airline industry changes please RECONFIRM your flight with the airline 24 hrs in advance. Be at the airport at least 2 hours in advance. You can book your air on-line directly with the carrier. It is extremely important that the names on the enclosed form are exactly as they appear on your passport, as incorrect name spelling may result in denied boarding.
